Thanks to our dedicated community, volunteers, and donors, we were able to meet and exceed those needs. We continue to explore creative ways to reduce costs while maintaining our high care standards.

We worked closely with Everett Animal Shelter and Regional Animal Services of King County to transfer 66 animals into our care to give them a second chance at adoption. We are happy to report that 64 of those 66 animals found their forever homes.

We closed out the year by celebrating our 25th Anniversary. We thank our community and donors for their continued support over the last 25 years.

Staffing

Staffing includes wages, taxes, and L&I insurance for staff. Staffing wages increased in keeping with WA State minimum wage increases. The addition of the Executive Director position also increased staffing expenses.

Other

Other include facilities, equipment expenses, fundraising expenses, fees, office supplies, utilities, insurance, and tax preparer fees.
